# **Activity 01 - Goals : Relationship to Public Street**

The **Goals Activity** first asked each participant to describe their relationship to Public Street. Below are a few quotes that were captured.

"I live in Warwick but work and spend a lot of time in Providence and I often bike/ drive right across public street. I find myself enjoying the parks and green space in Pawtuxet and India Point with little opportunity in between".

"I meditate & connect with nature on Public Street".

"I live in Providence. I have worked with + support goals of REJC and office of sustainability. I go to Public St. to access the waterfront."

"I live very close by in Washington Park for over 40 years."

"I live in the neighborhood and would like better access to the waterfront".

"I clean up off the shoreline. I advocated for designation of public street as a public right of way."

The **Goals Activity** recognized 16 goals for Public Street and encouraged participants to select their top three goals and why they are important. The goals that were included in the activity were taken from the results of a previous Public Street Community Engagement conducted in October 2021.
































The participants expressed that the goal for Public Street is to provide the residents with a space that will uplift and bring hope to the community. According to participants, this space should give the people a place to relax, rest, and allow for easy access to walk along the water. The pie charts documents the top goals for Public Street:

- 1. Green Space
- 2. Habitat Restoration
- 3. Access
- 4. Water Quality
- 5. Play + Exercise



## **Green Space:**



In addition to providing an outdoor space for residents and guest to frequently utilize, there is opportunity for health benefits with the use a green space.

Introduce big native canopy trees in South Providence. It is really difficult to find space for large trees and lush native planting/farming.

In need of a green space that that helps address air pollution while also providing the community with a calm space for the people of South Providence to explore and interact with nature.

# **Habitat Restoration:**



Can the environment we occupy sustain us if our system could not provide? By restoring habitat, there is an increase in ability to create food source space.

# **Water Quality:**



The river needs to be cleaned for the health of the rest of the bay to preserve existing wildlife and all this is connected.

Opens options for local resource use and reduces need for outsourcing and pollution. Water = Life.

Opportunity for stormwater filtration (on a small scale) to remediate flooding.

#### Access:



Features that welcomes access to the river for the community - need more of! May expand beyond just the the end of the street both along the shore and into the river.

Take into consideration of the natural landscapes history - would like a clear idea of what the green spaces would look like

There is currently no easy access to the water from the south side, the community needs a space that allows for everyone to capture the benefits of the views, nature, and connection to the water.

# Play + Education :



Create an opportunity for persons of all ages to be familiarized with the natural world in which they occupy. Could use the space for education on the environment and habitat.

Provide a comfortable space for light recreation and outdoor activities such as kayaking and kid friendly play materials.

# **Culture + Art:**



An environmental and cultural/social HUB that celebrates the past and present culture of the river itself.


Open space that prioritizes the arts, culture and history. Financial opportunities such as the making of art or a farmers market.




# **Other Options:**

- Water filtration
- Community Care
- Educational Benefits
- Oyster Farm that can include mussels and other food sources (after water is filtered)
- Solar Power Lights
- Native Plants
- Plants with air and water filtration mechanisms
- Outdoor Market Space
- Not too much of a sleek modern design
- Preference for Old industrial aesthetic with Cobblestone stamped surfaces.

# **Activity 03 - Challenges for Public Street**

#### **Pollution**

- -Pollution, odor, and noise from industries and vehicles
- Safety and water quality (toxic)
- Debris, physical disturbances

# **Safety**

- -Safety in an "isolated" space
- Access during different times of the day

#### **Environmental Factors**

- -Wind
- Enough green space?
- Invasive plants and animals

#### **Traffic**

- -Parking: is it necessary?
- Should redirect abutting businesses traffic away from Public St

## **Process : Questions / Concerns**

- How to market Public Street for leisure?
- Will DEM/CRMC permit barrier islands?
- What is the vision and influence of port/industry stakeholders?
- Will there be anti-displacement efforts to combat gentrification?
- Can space be publicly (community) owned?
- How much funding will go towards maintenance? Long-term after initial capital expense?
- Concern: Getting community input about how water is used recreationally.
- Concern: Community buy-in

## **Project: Design Concerns**

- Approach to the park, pedestrian accessible and walkable
- Inclusive to all abilities
  - Concerns:
- Maintenance and clean up
- Maintenance of education programs
- Obstruction between people and the water

# **Activity 03 - Opportunities for Public Street**

# **Environmental Aspects**

### [ Water + Quality ]

- A place on the water for fishing and habitat restoration
- Aquatic farming / aquaculture (oysters, kelp, algae, and other seafood)
- Using oyster fishery or other ecological solutions to mitigate pollution
- Stormwater management
- Water quality improvement
- Near the water and fresh air

#### [ Green Space ]

- Preservation of wildlife and green space
- Bio-Boardwalk (Williamsburg, Brooklyn)
- Native plants for pollinators
- A means to host native flora and fauna for support of local species
- Trees to help improve smells in the summer
- Incorporate natural elements with habitat and the ecological functions of the waterfront

# **Culture / History**

#### [Culture]

- Involve indigenous communities & incorporate indigenous art
- Community connection to Broad St & neighborhood
- Space reflective of neighborhood and culture
- Increase community engagement
- Stable and supportive space for the community

#### [ History ]

- Acknowledging/honoring history of immigration
- Cultural and ecological history
- Horse shoe history

# [ Qualities ]

Lighting

**Elements** 

- Painted super graphic, allows for creativity & color
- Boardwalk can include amphitheater
- Seating
- Signage on the corner of Allens Ave & Public St
- Pavers- openings for plants

- Avenue concept art piece
- A lot of unused land in the area allows for opportunity

# **Recreational Use**

#### [Learning]

- Education on oysters, biophilia and environment
- Field trip (K-12) and research sites (college + Universities)
- Outdoor classroom

#### [Connectivity]

- Walkway connection from Collier Point to Public St
