March 26, 27, and 28	Deadline to file disaffiliation - candidates Deadline to file disaffiliation to run as a candidate. If you wish to run as a candidate and are affiliated with a political party other than the party in which you wish to run, you must disaffiliate by this time. Deadline depends on date you file your Declaration of Candidacy. [RIGL § <u>17-14-1.1</u>]
May 25, 26, and 27	Deadline to register to vote - candidates Deadline for candidates to register to vote in order to be eligible to file a Declaration of Candidacy. Persons must be registered to vote at least 30 days before filing their Declaration of Candidacy. [RIGL § <u>17-14-1.2(a)]</u>
	File declaration on: Register to vote by: June 24, 2024 May 25, 2024 June 25, 2024 May 26, 2024 June 26, 2024 May 27, 2024
June 24, 25, and 26	Declaration of Candidacy filing period Dates for filing declarations to be candidates in primaries or to be independent candidates in the general election. Candidates for federal office and independent presidential electors file with the RI Department of State Elections Division. Candidates for general assembly, local offices, district committees, and local committees file with local boards of canvassers where the candidate is registered to vote. [RIGL §17-14-1]
June 27	Deadline to submit party nominations For any state office for which no primary nomination has been made and any local office for which no nomination has been made by any authorized city, town, ward, or district committee or any duly authorized subcommittee, state committees of political parties may file party nominations within 24 hours of the deadline for the filing of declarations of candidacy in the same location where the individual nominated would have filed their declaration of candidacy for such office. [RIGL § <u>17-12-2(3)</u>]
June 27	Deadline to file district committee endorsements District committees file with local boards of canvassers lists of candidates having district committee endorsement (senatorial and representative district committees from the City of Providence file with the RI Department of State Elections Division). To be filed not later than the day after the final day for filing declarations of candidacy. [RIGL §17-12-11(b)(2)(c)]
June 27	Deadline to file City/Town/Ward committee endorsements City, town, and ward committees file with local boards of canvassers lists of local candidates having committee endorsements. To be filed not later than the day after the final day for filing declarations of candidacy. [RIGL §17-12-11]

June 28	Deadline to file state committee endorsements State committee notifies the RI Department of State Elections Division of the endorsement of candidates to be voted statewide and by congressional district. To be filed not later than the second day after the final day for filing declarations of candidacy.
	State committee to file with local boards of canvassers lists of candidates having committee endorsement when city, town, or district committees failed or neglected to do so. To be filed within 24 hours after city, town, or district committees have failed to endorse. [RIGL $\S17-12-4$]
July 2	Pick up nomination papers First day nomination papers are available. Candidates for federal office and independent presidential electors (or their designees) obtain nomination papers from the RI Department of State Elections Division. Candidates (or their designees) for the following offices from the City of Providence obtain their nomination papers from the RI Department of State Elections Division: senator, representative, senatorial and representative district committees.
	All other general assembly, local office, district committee, and local committee candidates obtain nomination papers from local boards of canvassers where they filed their declaration of candidacy. Local board prepares within 2 business days of the final day of filing endorsements.
	Persons other than candidates picking up nomination papers from the RI Department of State Elections Division (148 W. River Street, Providence, RI) must have written authorization from the candidate. [RIGL $\frac{17-14-4(a)(c)}{2}$]
July 12	Deadline to submit nomination papers All candidates (or their designees) except electors for independent presidential candidates file completed nomination papers with local boards of canvassers. To be filed on or before the 60th day before the primary. [RIGL § <u>17-14-11]</u>
July 15	Deadline to file objections to candidates - local offices Final date to file objections to eligibility of candidates or sufficiency of nomination papers for local offices. Objections to be filed with the local board of canvassers the next business day after the final date for filing nomination papers. [RIGL § <u>17-14-13</u>]
July 15	Deadline to file withdrawals of candidates - local offices Final date for local candidates to file withdrawals of candidacy. To be filed where nomination papers were filed. Note: in the event an objection has been filed, withdrawal to be filed within 24 hours of decision. [RIGL §17-14-15]

July 17	Deadline for decisions on objections to candidates - local offices Local boards of canvassers to make decisions on objections to eligibility of candidates or sufficiency of nomination papers for candidates for local offices. Decisions to be made within 2 days of objections, exclusive of Sundays and holidays. [RIGL § <u>17-14-14(b)(c)</u>]
July 18	Deadline to certify nomination papers Last day for local boards of canvassers to file primary and independent nomination papers for federal and state offices, and certifications for local offices with the RI Department of State Elections Division. Local boards to file not later than 54 days prior to the primary. [RIGL § <u>17-14-12</u>]
July 19 at 5 p.m.	Ballot placement lottery for primary and general election The RI Department of State Elections Division will conduct a lottery to determine ballot placement for unendorsed federal and state party candidates on primary ballots. The lottery will be held at 5 p.m. at the RI Department of State Elections Division (148 W. River Street, Providence, RI). If decision rendered on objections removes a candidate involved in the lottery, candidate's name will be removed from the ballot. [RIGL § <u>17-15-8</u>]
	The RI Department of State Elections Division will conduct a lottery to determine ballot placement of recognized political parties and independent candidates (except electors for independent presidential candidates - see September 13) for the general election ballots. The lottery will be held at 5 p.m. at the RI Department of State Elections Division (148 W. River Street, Providence, RI). [RIGL §17-19-9.1]
July 19	Deadline to file objections for candidates - federal and state offices Final date to file objections to eligibility of candidates or sufficiency of nomination papers for all federal and state offices. Objections to be filed with the RI Department of State Elections Division by the next business day after the final date for filing nomination papers. [RIGL § <u>17-14-13</u>]
July 19	Deadline for withdrawals of candidates - federal and state offices Final date for federal and state candidates to file withdrawals of candidacy. To be filed where nomination papers were filed. Note: in the event an objection has been filed, withdrawal to be filed within 24 hours of decision. [RIGL § <u>17-14-15</u>]
July 22	Deadline for decisions on objections to candidates - federal and state offices State Board of Elections to make decisions on objections to eligibility of candidates or sufficiency of nomination papers for candidates for federal and state offices. Decisions to be made within 2 days of objections, exclusive of Sundays and holidays. [RIGL §17-14-14(a)(b)]
July 29	Deadline to submit list of poll workers - primaries City/Town committees submit names to local board of canvassers of registered voters who will serve as wardens, moderators, supervisors, and clerks. [RIGL §§ <u>17-11-11</u> , <u>17-15-13</u>]

August 6	Deadline to appoint poll workers - primaries Local boards of canvassers to appoint wardens, moderators, supervisors, and clerks at least 35 days prior to the primaries. [RIGL §§ <u>17-11-11</u> , <u>17-15-13</u>]
August 7	Deadline to submit local questions Local boards of canvassers to certify to the RI Department of State Elections Division a copy of each question to be submitted to the electors of the city or town. To be done not later than the 90th day before the general election. [RIGL §17-19-7]
August 10	Deadline to post canvass notice - primaries Local boards of canvassers to post and advertise notice of canvass at least 10 days prior to canvass. Notice to be posted not later than August 10 th in order for canvass to be conducted by August 20 th . [RIGL § <u>17-10-5(a)]</u>
August 11	Deadline to register to vote and to file disaffiliation - primaries Final date for voter registration for primaries. Registration must be made at least 30 days prior to the primary. [RIGL §§§ <u>17-1-3</u> , <u>17-1-7</u> , <u>17-9.1-3</u>]
	Deadline for voters to disaffiliate (if necessary) in order to vote in a different party's primary. If you wish to disaffiliate you must do so at least 30 days prior to the primary. Unaffiliated voters may vote in any party's primary. [RIGL §17-9.1-24(a)]
August 16	Deadline to post preliminary voter lists Local boards of canvassers to prepare and post preliminary lists of voters eligible to vote in the primaries. To be posted forthwith after close of voter registration for the primary.
	In accordance with RIGL § <u>17-9.1</u> , certain registrations processed on the last day to register to vote are allowed a 5-day transmittal period. Accordingly, local boards of canvassers cannot prepare and post preliminary lists of eligible voters until after this 5-day transmittal period. [RIGL § <u>17-10-3(a)]</u>
Within 5 days of posting	Deadline to file affidavit of names erroneously included or omitted from voter list
of preliminary voting list	Affidavit to be filed with local boards of canvassers by person claiming that their name has been erroneously included or omitted from the preliminary voting lists. To be done within 5 days of posting of preliminary voting lists. [RIGL §17-13-2]
August 20	Deadline to submit mail ballot applications - primaries Final date to submit application for a regular mail ballot for primaries. To be received by local boards of canvassers not later than 21 days prior to primaries. [RIGL § <u>17-20-2.1(c)</u>]

August 20	Deadline to submit Braille or tactile mail ballot applications Final date for those voters who are blind, visually impaired, or disabled to request a Braille or a tactile primary mail ballot from their local board of canvassers. [RIGL §17-19-8.1(b)]
August 20	Deadline to canvass voter lists Local boards of canvassers are to canvass and correct voting lists before the 20 th day prior to primaries (20 th day is August 21 st – must be done before this date). [RIGL § <u>17-10-5(a)</u>]
August 21	Deadline to post final voting lists - primaries Local boards of canvassers to post final corrected copies of voting lists for primaries. [RIGL §§ <u>17-10-5(a)</u> , <u>17-10-14</u>]
August 21	Early voting and emergency mail ballot period begins Period begins for voters to vote early at a location designated by their city or town. Early voting period ends on September 9, 2024 at 4 p.m. [RIGL § <u>17-20-2.2</u>]
	Period begins for voters to apply for an emergency mail ballot with their local board of canvassers if they need to request a mail ballot after the August 20, 2024 mail ballot application deadline. Emergency mail ballot period ends on September 9, 2024 at 4 p.m. [RIGL § <u>17-20-2.2(a);(b)]</u>
August 23	Deadline to certify mail ballot applications Final day for local boards of canvassers to certify mail ballot applications to the RI Department of State Elections Division (not later than 18 days prior to the primaries, or within 7 days of receipt, whichever occurs first). [RIGL §17-20-10(c)]
August 30	Post notice - primaries Local boards of canvassers to post notice of primaries in each voting district. To be done at least 8 days prior to primaries. Local boards
	of canvassers may substitute posting of notices by publication in the newspaper (September 2^{nd} is Labor Day). [RIGL § <u>17-15-17</u>]
September 3	Appointment of party officials - primaries Local boards of canvassers to appoint watchers, checkers, and runners for primaries. Appointments to be made from lists provided by city and town party committees at least 10 days prior to the primaries. August 31 is a Saturday, September 1 is a Sunday, and September 2 is Labor Day. [RIGL § <u>17-15-13(c)</u>]
September 6	Deadline to submit nomination papers - presidential electors for independent presidential candidates All presidential electors for independent presidential candidates submit nomination papers to local boards of canvassers. To be filed on or before the 60th day before the election. [RIGL §17-14-11]

September 9 at 4 p.m.	Early voting and emergency mail ballot period ends Period ends for voters to vote early at a location designated by their city or town. [RIGL § $17-20-2.2$]
	Period ends for voters to apply for an emergency mail ballot with their local board of canvassers if they need to request a mail ballot after the August 20, 2024 mail ballot application deadline. [RIGL § <u>17-20-2.2(a);(b)]</u>

September 10 at 8 p.m.	[RIGL § <u>17-15-1</u>] Deadline to receive mail ballots Final date for receipt of mail ballots by State Board of Elections for primaries. Must be received by the State Board of Elections at 2000 Plainfield Pike, Cranston, RI 02921 or in an authorized elections drop box not later than 8 p.m. [RIGL § <u>17-20-16</u>]
September 11	Tabulation of returns Local boards of canvassers to meet and tabulate city and town primary returns as the case may be, and announce results. Certificates of nomination or election not to be issued until expiration of period for requesting a recount, and if a recount is requested, following decision thereon. [RIGL § <u>17-15-30(a)</u>]
September 11 by 4 p.m.	Deadline to submit recount requests Final date for candidates to request State Board of Elections to conduct a recount of votes cast at a specific voting location or locations, or for filing other protests concerning the primary. Must be filed not later than the day following the primaries. [RIGL § <u>17-15-34</u>]
September 12	Deadline to certify nomination papers - presidential electors for independent presidential candidates
	Local boards of canvassers to file nomination papers for presidential electors for independent presidential candidates with the RI Department of State Elections Division. Local boards shall certify nomination papers to the RI Department of State Elections Division not later than 54 days before the date of the election. [RIGL §17-14-12]
September 12	Deadline to certify names of party and independent presidential candidates
	The secretary or duly authorized individual of each national party shall certify to the RI Department of State Elections Division the names of individuals nominated as the party's candidates for president and vice president. The names of independent candidates for president and vice president must also be submitted by the authorized individual for those political organizations that have qualified independent presidential electors. By regulation adopted May 15th, 1996 to be filed not later than 54 days before the date of the election. [RIGL §17-14-12]

September 13 at 4 p.m.	Deadline to receive military and overseas mail ballots
	Final date for receipt of military and overseas mail ballots by State Board of Elections for primaries. Must be received by the State Board of Elections at 2000 Plainfield Pike, Cranston, RI 02921 not later than 4 p.m. [RIGL § <u>17-20-16]</u>
September 13	Deadline for voters to return deficiency notices regarding their mail ballots to the State Board of Elections
	Deadline for voters to return deficiency notices regarding their mail ballots to the State Board of Elections. [RIGL \S <u>17-20-26</u>]
September 13	Deadline to fill vacancies Final date for filling vacancies caused whenever a nominee of a recognized political party removes themselves from the jurisdiction of the district or as a candidate for the office for which the nominee seeks election. In the event of death, the vacancy can be filled at anytime. Vacancies must be filled at the same location where the individual would have filed their declaration of candidacy. [RIGL § <u>17-15-38(a)</u>]
September 13	Local candidates certification
	Local boards of canvassers to certify to the RI Department of State Elections Division the names of candidates for each local office and the party name under which they were nominated, and the names of all qualified independent candidates for each local office. To be done not later than the third day following the date of the primaries. [RIGL § <u>17-19-7]</u>
September 13	Deadline to file objections to nomination papers - presidential electors for independent presidential candidates
	Final date to file objections to nomination papers for presidential electors for independent presidential candidates. Objections must be filed by the next business day after the final date for filing nomination papers. [RIGL § <u>17-14-13</u>]
September 13	Deadline for nomination withdrawals - presidential electors for independent presidential candidates
	Presidential electors for independent presidential candidates file withdrawals with the RI Department of State Elections Division. If an objection has been filed, withdrawals may be filed within 24 hours after the State Board of Elections renders its decision. [RIGL § <u>17-14-15</u>]
September 13 at 5 p.m.	Ballot placement lottery - presidential electors for independent presidential candidates
	The RI Department of State Elections Division shall conduct a lottery to determine ballot placement of presidential electors for independent presidential candidates for the general election ballots. Lottery will be conducted at the RI Department of State Elections Division, 148 W. River St., Providence, RI. (If decision rendered on September 16th removes presidential electors for a particular presidential candidate, the names will be removed from the ballot.) [RIGL §17-19-9.1]

September 16	Deadline for decisions on objections to candidates - presidential electors for independent presidential candidates
	State Board of Elections to make decisions on objections to nomination papers for presidential electors for independent presidential candidates. Decisions to be made within 2 days of objections, exclusive of Sundays and holidays. [RIGL § <u>17-14-14</u>]
September 23	Deadline to submit list of poll workers - General Election
	City/Town committees submit names to local board of canvassers of registered voters who will serve as wardens, moderators, supervisors, and clerks. [RIGL §§ <u>17-11-11</u> , <u>17-11-13]</u>
October 1	Deadline to appoint poll workers - General Election
	Local boards of canvassers to appoint poll workers for the general election. Appointments to be made from lists provided by city and town committees at least 35 days prior to the general election. [RIGL §§ <u>17-11-11</u> , <u>17-11-13</u>]
October 5	Deadline to post canvass notice
	Local boards of canvassers to post and advertise notice of canvass at least 10 days prior to canvass. Notice to be posted not later than October 5 th in order for canvass to be conducted by October 15 th . [RIGL § <u>17-10-5(a)</u>]
October 6	Deadline to register to vote - General Election

December 17 at 12 p.m.	Meeting of Electoral College Meeting of presidential electors to be held at the State House at noon. [3 U.S.C.1 §1-22]

Note: "NOTICE OF ORGANIZATION"

Any candidate for public office, as defined in §<u>17-25-3</u>, is required to file a "Notice of Organization" with the State Board of Elections prior to receiving any contributions or expending any money in the furtherance or aid of their candidacy or at the time of filing their declaration of candidacy, whichever occurs first. (Note: Persons who have a "Notice" on file with the State Board of Elections and who regularly file reports with the Board are required to file an amended "Notice" whenever there is a change to information therein contained.)
