### **Status of 246 Prairie Avenue**

Acquired by the Providence Redevelopment Agency (PRA) in late 2022 following Urban League announcement.

Environmental assessment recently complete.

Informational signage installed.

As previously announced, the existing building is unsafe.

Abatement near completion, demolition beginning in coming weeks.


